Thank you for your freedom of information request received in this office on **18 March** 2024 in which you asked:

'I write further under the subject access request and the freedom of information request act to request a more detailed list of were and what the money was spent on in regards to \$.582 also £123..920 and also £76.400 as I am concerned as a taxpayed about the amount of money that has been spent in particular while Quinton police station has been closed.'

In response to your request, I can confirm that the Office of the Police and Crime Commissioner (OPCC) holds the following information:

- 1. The £4,582 breaks down as:
 - a. Uninstalling of Gateway £230
 - b. External Cameras and Signage £1,100
 - c. Recycling of Furniture £640
 - d. Removals and Clearance £2,612
- 2. The £123,920 which represent the costs whilst the site was closed break down as:
 - a. Planned, Reactive and Grounds Maintenance etc £29,892
 - b. Utilities £23,562
 - c. Rates (includes Rebates) £64,210
 - d. Professional Services £6,256
- 3. The £76,400 cost represents the costs for recommissioning the site (building works) following a period of being sat empty to make it habitable again and to ensure it meets the new Operating Model requirements. This includes for but not limited to at this stage:
 - a. general repairs
 - b. security works
 - c. plumbing
 - d. data/power changes
 - e. decorations

Please note, the costs continue to be reviewed as we work through the site and confirm final elements of the works, so this is not the final figure. We will happily provide final costs by way of a follow up FOI, if required, once the works are complete and the teams have relocated.

Freedom of Information Right of Appeal

Any person who has requested information from the Office of the Police and Crime Commissioner (OPCC) and is unhappy with the way their request for information has been handled can request a review of their case.
